Vape Pen Disposal Nicotine & Batteries

Vape pens have a poor reputation in the waste sector, and part of the reason boils down to two components – nicotine-containing liquids, and lithium-ion batteries.

Nicotine can be toxic when ingested, absorbed through the skin, or inhaled in large amounts, while lithium-ion batteries pose a serious fire risk and a source of heavy metals when damaged. Both components can be a danger to human and environmental health, and both are commonly regulated as hazardous waste under RCRA.

This presentation will cover what vape devices are, their usage and disposal trends, key safety considerations, and RCRA compliance concerns in Kansas.

Jacob Larson is a pollution prevention specialist at K-State's Pollution Prevention Institute (PPI). He provides technical assistance to Kansas businesses on sustainability initiatives and environmental regulations – focusing on RCRA – through PPI's Small Business Environmental Assistance Program.
