Funding

- Maintain the resources and programs we currently have
- Determine what the best program would look like and ask for it
- Develop a funding formula
- ASBO didn't spend what they had leading to a \$90,000 funding cut.
- With the new administration interested in small business, we now have an opportunity to try to expand funding, program support, and SBEAP programs themselves.
- Need to stabilize program funding
 - O How do other agencies fund their program?
 - Nothing specifying how much funding for SBEAPs add SBEAPs in PPG or statutory reform specifying funding?
- SBEAPs need to tell EPA what they need current administration wants to know what businesses need
- Show number of small businesses vs. SBEAP employees to show where we're underfunded
 - SBA has reports by state, industry, number of employees, etc. to reference

SBA Roundtable Involvement

- Help decide where SBA roundtables take place
- Help get businesses there be proactive
- Potential workgroup to create roundtable "packets"?

Multimedia Programs

- Expand multimedia programs / work with EPA on different media
- Keep Technical Subcommittee multimedia or separate different media types?

CAPs

- CAPs can speak for and promote SBEAPs
- Establish national network of CAPs?
- Re-establish national CAP possible new workgroup?

Interaction with New EPA Administration

- Regulatory Accountability Act could we get involved?
- Joan emphasizing individual states send letters, more impactful than from NSC
 - o Trade associations, CAPs, partners should also send letters
 - Possible letter trade associations could sign onto to show their support of SBEAPs? Each state signs on? Could use regulatory reform letter as a start.

Promoting Programs

- Prioritize getting flier publicized Promotional Subcommittee
 - Send to heads of SBA and regional administrators
 - Trade associations can help distribute

Annual Training

- Susan Tripp has list of responsibilities to aid future Planning Subcommittee chairs
- \$88,000 EPA grant for training every other year coming soon
- EPA used to pay for NSC meeting in D.C. half way through the year in addition to Annual Training
