### **Big Wins**

- a. Arkansas Department of Energy & Environment's Enterprise Services facilitated the transition of more than 400 staff to remote work status, working across Human Resources and Information Technology programs that had not yet been fully merged after State Transformation.
- b. Enterprise Services wrote the Division of Environmental Quality (DEQ) Provisional COVID-19 Enforcement Policy, responded to all multi-media and trade organization inquiries regarding COVID-19 response and policies, and tracked all requests for regulatory relief related to COVID-19 for the department.
- c. Enterprise Services brought all responses to National Environmental Policy Act (NEPA) projects under one roof, resulting in a 129 percent increase over the previous year. (Before this change, NEPA requests were handled throughout the agency by individual media offices.)
- d. Assisted the state economic development agency with projects that have potential investments of more than \$2 billion.
- e. Authorized \$178 million in tax credits for recycling equipment.
- f. Continued developing the Natural State Environmental Program (NStEP), to promote voluntary environmental stewardship in Arkansas.

# **Challenges**

Enterprise Services is currently rebuilding its SBEAP, effectively from scratch. Two of our four staff members joined Enterprise Services in the past year; a third staff member joined us at the end of January 2021. This new member will be the primary lead for our SBEAP program. The fourth member works exclusively on the Recycling Tax Credit program.
