Auto Body ERP*

In this session, Renee Bashel will be presenting the results of the Region 5 Autobody Environmental Results Program conducted from 2009 to 2012. We measured the change in performance for autobody shops in our urban counties with respect to compliance with the Area Source NESHAP in 40 CFR Part 63, subpart HHHHHH, or as we all have come to know it "6H". We measured their level of compliance with 6H before the SBEAPs provided compliance assistance, and then again after the compliance deadline in 2011 through inspections conducted by EPA Region 5 air inspectors. Where did the shops improve the most? How did compliance assistance play a role? How did this partnership between SBEAPs and EPA staff work? Please join us for this session if you would like answers to these questions and a few others.
