## A Powerful Economic Driving Force

- Small businesses make up 99.7% of all US businesses, with 90% of U.S. businesses employing fewer than 20 staff.
- Over 75% of new jobs are generated by small businesses.
- Small businesses represent 97% of all exports and 52% of private sector products in the U.S.

# **State Small Business Assitance Programs Small Programs with Big Impacts**

- Small Business Assistance Programs (SBAPs) have been providing air-only compliance assistance to small businesses for over 10 years.
- Using average budgets of \$300,000 and average staffs of 4 full-time employees, the SBAPs helped over 5 million small businesses between 2001 and 2003.
- SBAPs are funded by the states and receive no federal funding.

# The Challenge

## **Too Many Places to Go to Get the Answers** Small Businesses Need—Time is Money!

#### For Small Businesses:

Time-Consuming: Separate offices for air, water, and waste issues make it difficult for businesses to get their answers quickly.

## "Small business operators don't have time to run around chasing down regulations!"

High Compliance Costs: Environmental compliance costs are the largest regulatory cost to small businesses—almost 50%.
