#### Annual Training

- EPA Region 9 speaker: Morgan Capilla, Environmental Justice Coordinator; or someone from her office. (45 minutes)
- Subcommittee overview: Maxwell Graham review of draft outline
  - Add discussion on cumulative effects. EPA is starting to consider / define. Small businesses may come into play since they're looking at all pollution sources.
    - Jenifer Dixon has experience in this area she can share.
    - NJ also considering cumulative impacts. Both major and minor air sources have been impacted.
    - Lot of questions about how to quantify. Climate and Environmental Justice Screening Tool doesn't address cumulative impacts. EPA doesn't have much guidance.
    - Nancy Larson heard from the KS environmental agency that, according to a committee they're on (maybe ECOS?), PA and CO both have strong programs. Nancy will find out more information.
  - Housing issues may come into play. Many areas converting old industrial buildings into housing, moving people into existing industrial areas. Are existing environmental issues considered when deciding where to put housing? Might be a zoning question. Renovations should at least trigger asbestos notifications. Environmental issues may be considered if property is already considered a brownfield.
  - We haven't been given much information about EPA assistance efforts beyond enforcement.

- Guest speaker: Jamie Marincola; Stormwater, Wetlands and Oil Supervisor; Enforcement and Compliance Assurance Division, EPA Region 9
  - o A recording of the presentation is available on the EJ Subcommittee web page.
  - Jamie spoke on collaborative efforts between EPA Region 9 and California EPA regarding environmental justice.
  - They have an MOU and EJ Enforcement Action Plan focused on strategic inspection targeting, enforcement actions and community engagement.
  - Key elements of their work involve locally focused enforcement, rapid response to environmental events, a coordination toolbox to streamline the inspection process for businesses, and locally focused enforcement including the use of supplemental environmental projects (SEPs).
  - Much of their work is based on community complaints.
  - These efforts are currently being piloted in five communities where they can work with community groups to identify environmental concerns.
  - They also work with businesses within the target communities and sometimes need to mediate between them and communities when the business is in compliance, but the community still wants to shut them down. An example was provided of a scrap metal business next to a school. They also do a lot of outreach to businesses that don't know they need a storm water permit and on spill prevention.
  - Other EPA regions are considering doing similar things to Region 9.

#### Questions and discussion with Jamie

- Michigan is looking into a potential project bank for SEPs for the Detroit area. Guidance from EPA would be helpful. EPA stopped doing SEPs under the last administration but has since brought them back. They have not done SEP banks (except for wetlands which is a similar concept). Some businesses prefer SEPs to paying money to a general fund. However, SEPs can be complicated and agencies don't always have the time or expertise to manage them. But it is a good way for the business to give back to the community.
- Some states don't want to talk about environmental justice. EPA has not imposed EJ requirements on states and their efforts are voluntary EPA is trying to lead by example. Todd noted that Ohio is working on lead line replacements and providing water bottle refill stations and that EJ is not only about race but also includes economic factors.
- EPA is going outside their current universe of facilities to identify businesses are regulated but might not know. They have developed a tool to help identify businesses that may need a storm water permit.

#### Annual Training recap and discussion of ideas

- o Surprised that in some states EJ is considered a "dirty word."
- Annual Report data: 85% of respondents are not tracking EJ-related activities. Of those that are, 80% are using EJ Screen. One program indicated they did not recognize EJ in their state.
- Several attendees indicated they would like training on the different EJ screening tools. Could discuss the difference between them and what to use when.
- Could review analytics on subcommittee page to see what people are using.
- NEJAC section on web page Weren't able to get a nominee on the NEJAC but could keep the section with some general information and public meeting announcements.

## Question: Is anyone applying for EPA's P2 grant for EJ communities?

Sam H. interested in talking to other states looking at this grant.

- WI considered applying for grant for their Green Tier (beyond compliance) program as part of a new climate charter. Not specifically for SBEAP but do want to recruit small businesses.
- Deb: IL has partnered with Missouri and Iowa on Mississippi River corridor.
- Org in Chicago interested in partnering to get funds for landscapers in EJ areas to purchase electric equipment.
- Also an EPA P2 grant for safer products.
- o TN may apply for grant to do something similar to OH's Permit Wizard.

#### What's next?

- Training on EJ screening tools or other EJ topics open to SBEAP Main. Maybe quarterly.
- Case studies/examples of working with businesses to address EJ concerns / show practical applications.
  - Successes/failures working with community groups.
  - Has anyone had success bringing small businesses to the table with communities?
- Review outreach flyer for businesses during June call.
- Metrics easy ways to determine if businesses are in disadvantaged communities?
  - KS is adding EJ tracking to their database and Mary can talk about it once it's integrated. Automatically determines if contact is in an EJ community using address and census data. Makes tracking easier so doesn't take too much time to enter data.
  - Most programs track SBEAP efforts in a database or Excel spreadsheet but looks different in every state.
  - Excel function can help make EJ determinations. Typos can cause issues since it's an automated process.
- Reach out to SBDCs to see if EJ is on their radar. Connect with other assistance providers.
- O Potential future topic EPA/state enforcement partnership policy EPA has authority to step in if state isn't adequately addressing an issue. EPA may take the lead on "actions to advance important national policy priorities. In addition to NECIs, EPA may have overarching national policy priorities and goals where compliance and enforcement actions by EPA may be needed (e.g., lead contamination and environmental justice)." Could impact states not addressing EJ.

- What mapping tools exist and what each one is used for. (EPA P2 EJ Facility Mapping Tool, etc.)
- How to identify overburdened communities in your state that may be targeted for EPA enforcement. Could use ECHO.
- o Talk with a state agency EJ advisor.
- Working with undocumented people.
- EPA looking at local governments for EJ actions? Maybe if they get EPA funding.
- Working with Tribes.
  - Not under state jurisdiction but many states will still help them if contacted.
  - White House tool best for tribal questions.
  - Tribes don't want to automatically be considered EJ communities.
  - Who to refer them to if SBEAP can't help? Hard to find compliance assistance other than the Compliance Assistance Centers.
  - Section 507 doesn't say anything specifically about Tribes. Just says to help small businesses.
  - Some states very particular about how they deal with Tribes. SBEAPs may not be able to work with them.
  - EPA provides STAG grants to Tribes similar to state agencies.
  - Could ask SBEAP Main who's worked with Tribes.

- Training ideas
  - EPA Region 4 EJ staff discuss initiatives, priorities in region, any business engagement (Annual Training)
    - Donovan will ask the Region 4 RASBL about connecting with someone.
    - Might be a challenge since it was hard to get someone to speak from EPA Region 9 for Nevada training. They didn't see the connection between what they do and SBEAPs.
  - Jalonne White-Newsome, Senior Director for Environmental Justice at White House Council on Environmental Quality
    - Spoke at MI EJ Conference and was very good.
    - May be willing to come to annual training. Good info on Justice40 Initiative.
  - Local or state government or community group EJ efforts (TN Annual Training)
    - Donovan will connect with Roni Atkins with their state agency's Office of External Affairs who has been involved in EJ.
    - Donovan will also reach out to a professor at Fisk University who is on their CAP and active with EJ in the community.

Could do panel with regional, state and local representation to see how they're
accomplishing their EJ goals on the ground and where they might need help. Could
give us ideas of things to focus on.

### Tracking outreach to businesses in EJ communities

- KS is integrating Climate and Economic Justice Screening Tool (CEJST) into their database for tracking site visits and calls when an address is given. Uses API for census data. Tracks contacts after the fact.
- KS also created spreadsheet identifying census tracks for targeted outreach. They are interested to learn how other states are doing this.
- Accessibility best practices (translating documents/web pages/site visits/phone calls; accessibility using alt text, spelling out email addresses, etc.)
  - Mary will reach out to Abby since she attended an accessibility event. Will share any contacts.
- Networking with agency EJ staff could hear from a couple
- Panel of state EJ leaders (MI, NH, PA)
  - Include discussion of state-specific mapping tools.
  - MI has a good state screening tool. Overlays with CEJST, includes PFAS info.
- List of screening tools and uses
  - Easier to do online than in-person.
  - Focus on national tools before getting into state tools.
  - EJScreen 2.2 new index includes air toxic releases using TRI data. Can overlay with EJ indexes or view on its own. Updates to reports that can be generated. Overlays with CEJST for determining if a community has EJ concerns.
  - Could be hands on, take a couple example businesses or communities to demo what info is available and how it can be used.
  - Matt Lee did a great demonstration of the update for EJ screen 2.2. Here are some training links:

- How to use EJ flier to increase business awareness (when complete)

- SBEAPS working with tribes
  - Oregon and Washington have good relationships with Tribes. Could share ideas on how they have been successful in communicating with Tribes.
- Open anyone have experience with events that bring communities and businesses together?
  - KS has roundtable coming up with chemical manufacturing speaker. Wants community-based organizations to attend as well.
  - How to handle childcare, transportation, food, etc.

- MI EJ Conference had info on how to hold events (i.e. keep events from 1 to 1.5 hours, make sure public transportation is available, hold meetings after work hours, provide food.
- Events with businesses and community members can get heated.
